**Absa Bank Limited, including all of its subsidiaries, having its head office at 15 Troye Street, Johannesburg, South Africa, is committed to maintaining the privacy and security of your personal data collected by us and on our behalf, whether in hard copy or electronic form. Absa's strategic partner, Fundi Capital (Pty) Ltd, will be collecting and processing your personal data on Absa's behalf for purposes of administering the Absa Fellowship & Internal Scholarship Programme application and management process.*

**Personal data is defined as information that allows us to identify you as a natural person or, where applicable, as a corporate entity (such as a company or trust). Absa Group is collecting this data to assess your application for a fellowship/internal scholarship and, if successful, provide you with the fellowship/internal scholarship.*

**Unless otherwise specified, you need to provide all of the personal data requested on this form. If you do not provide us with the required information, you will not be able to apply for the Absa Fellowship/Internal Scholarship.*

**We may carry out further processing on your personal data for historical, research and statistical purposes or to comply with our legal obligations. We will not engage you in any electronic direct marketing (excluding telemarketing), unless you have given us the relevant consent.*

**We will also use your personal data for carrying out automated decisions that may impact you. If you are unhappy about the outcome of the decision, please contact -*

**Where necessary, we may share your personal data within the Absa Group and with other third-party service providers, including credit bureaus that process your personal data in conjunction with us or on our behalf. These third-party providers, whether local or trans-border, are contractually obligated to process your personal data in line with our privacy and security policies. Our third parties may be located within your country of residence or in another country. When appropriate, we may also share your personal data with regulators or other crime-fighting agencies.*

**We will keep your personal data only for as long as we have to in terms of applicable laws and regulations. After this time, your personal data will be securely destroyed or de-identified.*

**To the extent that local legislation permits or if you are a resident of the European Union or United Kingdom, you have the following rights regarding your personal information:*

To access your personal information that we have on record.

To ask Absa to correct any incorrect personal information. These requests must be sent to us in writing.

To ask Absa to delete or destroy your personal information. You can also object to Absa processing your personal information. These requests must be sent to Absa in writing. However, if you ask us to do this the Absa Group may have to suspend the provision of the fellowship / internal scholarship for a period of time, or even terminate its relationship with you. The Absa Group's records are subject to regulatory retention periods, which means we may not be able to delete or destroy your personal information immediately upon request.

You may also ask the Absa Group to port your personal information to another party in terms of applicable European Union and United Kingdom data privacy legislation.

**If you have a complaint relating to the protection of your personal information, including the way in which we collected or processed it, please contact us. If you believe that your complaint was not dealt with satisfactorily, you may lodge a complaint with your local privacy regulator.*
